PURPOSE OF ROLE:

- The Tree Officer is part of an ambitious team providing our customers and colleagues with high quality, customer focussed, timely and outcome-based Development Management Service.
- You will need to deal efficiently and effectively with all aspects of planning work related to trees on private land, trees in conservation areas and trees protected by tree preservation orders and provide advice on high hedges and landscape design. This will include the making / updating of tree preservation orders, dealing with all types of applications for works to trees, acting as an expert witness in tree matters for all types of appeal or hearings and the provision of specialist advice on the care, management and planting of trees and shrubs.

KEY ACCOUNTABILITIES:

- 1. Provide Arboricultural advice to planning officers, applicants and developers, to inform the appropriate determination of planning applications having regard to relevant legislation and adopted planning policy.
- 2. Plan, manage and deliver clear recommendations in accordance with agreed timescales, the provision of Arboricultural advice and the processing of relevant applications to contribute to the provision of a high quality, responsive Development Management service.
- 3. To prepare and present written and oral reports and briefings to Members, Cabinet, Planning Committees, Members' Forum and other bodies, and to attend and lead meetings with Members as necessary.

- 4. Process high hedges complaints in line with the legislation in a timely and proactive manner.
- 5. Provide advice and recommendations in support of the Council's enforcement function against unlawful tree works.
- 6. Take responsibility for maintaining an up-to-date CPD record including the delivery of appropriate training to the wider development Management team as appropriate.
- 7. Implement the Local Planning Authorities Statutory Duty for the preservation and protection of trees when granting planning permission.
- 8. Actively manage and review the accurate recording and processing of tree work applications and retention of the statutory TPO register.
- 9. Where required represent the Council through the planning appeals process in relation to trees, including written representations, formal hearings, public enquiries and provide planning enforcement.
- 10. Contributing to service improvements to achieve cost efficiency and effectiveness whilst project managing your work to ensure KPI's are met/exceeded in terms of timeliness and quality of output, adding value wherever possible.
- 11. To act as mentor, role model and provide support to other staff within the wider service.
- 12. Undertake any other duties required by the business commensurate to the role.
