### 1. Primary Purpose of the Post

The role will assist with the delivery of day-to-day preventative action across all infrastructure areas and will support the IT Service Centre in dealing with 3<sup>rd</sup> line issues and major incidents.

- Work with the IT Governance and Compliance team to ensure best practice is followed in delivery of digital services

- Assist in the review of 3rd party supplier performance
- Assists in the development of plans for IT infrastructure to ensure the organisation is advancing its digital first agenda and creating service excellence for end users.
- Assist in the development and testing of service area Business Continuity Plans and infrastructure & cloud Disaster Recovery Plans (DRP)
