### **BASIC JOB PURPOSE**

To undertake, normally under supervision, the preparation, simple cooking, serving and clearing away of food and general cleaning

MAIN RESPONSIBILITIES
Basic preparation of food and beverages including simple cooking.
Transporting and serving of meals.
General kitchen and dining room duties e.g. washing up, setting up and clearing away of equipment/tables.
General cleaning of kitchen, surrounds and equipment.
Receive payment for meals and give appropriate change using electronic till as necessary.

Notwithstanding the detail in this job description, in accordance with the Council's Flexibility Policy the job holder will undertake such work as may be determined by the Director/Corporate County Manager from time to time, up to or at a level consistent with the Principal Responsibilities of the job and in any location within the Cheshire West and Chester.

# **OCCASIONAL TASKS**
