### Purpose

Lead on a wide range of technical, procedural and legislative matters in a professional, customer focused, and specialist technical service. Including having accountability for the delivery of a range of technical traffic management projects, initiatives or work packages that comply with relevant legislation and help achieve the Council's corporate aims and objectives. Using technical knowledge and expertise to develop, design and implement customer-focused solutions and continually identifying and championing opportunities to deliver improvement.

## Main Duties And Responsibilities

#### Behavioural:

- Enjoy, achieve, create impact, and thrive in the role and organisation.

- Resilient in the face of strong opposition to service position and often conflicting priorities.

#### Team Leadership and Management:

- Responsible for the supervision of highway contractors including agency staff such as transport consultants.
- Manage the workload of junior technicians when they rotate around the highways services as part of their career professional development.
- Management of the traffic signs and road markings revenue budget for traffic management in order to deliver efficient services within budget and ensure other service groups and associated contractors demonstrate efficiencies in order to reduce costs.
- Provide strong leadership, strengthening engagement, growth, culture, innovation, collaboration and performance.
- Assign responsibilities, setting clear expectations, and deliverables to team members and empower them to excel in their roles.
- Through continuous improvement strengthen the tools, practices and impact of the service.

#### **Communication, Engagement and Training:**

- Provide technical expertise, advice and support on behalf of the directorate and its clients on all aspects of road safety and traffic management improvement works and the introduction of TROs.
- Attend meetings, deputising for the Senior Network Manager/Team Leader with both internal and external stakeholders.
- Provide highly developed knowledge and professional experience in negotiation and collaboration with contractors, developers, external agencies and other local or government authorities in the delivery and improvement of services relating to the effective management of traffic flows on the network.

#### **Data Analysis and Decision-Making:**

- Lead on the technical delivery/approval of traffic engineering projects including parking restrictions, movement orders, residents parking and traffic management schemes ensuring compliance with current design guidance and legislation.
- Responsible for the design, consultation and delivery of traffic management schemes involving traffic signs and road markings, and undertaking traffic engineering design feasibility.
- Manage the Traffic Regulation Order (TRO) process from inception to completion (prepare • approval reports, consultation, liaison with legal services to check drafted legal notices, plans and orders and implementation)
- Responsible for the drafting of legal TRO schedules, production of technical drawings and • contribute to effective administration and management of TRO records to ensure that robust enforcement can be undertaken, and challenges defended.
- Support with managing and utilising network and traffic data and surveys, together with • feedback from internal departments and external agencies regarding plans and strategies for effective management of the network.

#### **Compliance:**

- Adhere to and comply with all relevant corporate policies and procedures including Health & Safety, General Data Protection Regulations (GDPR), Corporate Governance and Code of Conduct.
- Ensure that all service initiatives adhere to relevant legislation, policies and practices.
