MAIN PURPOSE OF POST:	Undertake structural engineering services for projects relating to Chesterfield Borough Council and external clients as required.	

DUTIES AND RESPONSIBILITIES:

Duties and responsibilities must be undertaken to comply with Council policies/procedures.

1.	Undertake assessment, implement and supervision of the Council's housing and non-housing repairs and maintenance requirements with regards structural issues, including external clients.
2.	Respond to and provide technical support and advice including compliance with Health & Safety regulations & other statutory duties of Designer, Client, Client Agent & Principal Designer as imposed by the Construction (Design & Management) Regulations.
3.	Lead on and undertake the preparation of technical formal reports including tender/contract documents, tender analysis and cost estimates.
4.	Carry out budget preparation and monitoring of expenditure for any scheme of works relating to structural repairs.
5.	Lead on concept and detailed analysis/designs and drawings relating to Civil and Structural Engineering and building projects including the appraisal of internal and external designs, undertaken by other specialists.
6.	Undertake with geotechnical engineering, including site investigations, foundation engineering, contamination, land reclamation, also providing advice to CBC Departments and private developers.
7.	Checking of structural calculations submitted by developers and 3 rd party sub-contractors for compliance with current building regulations and latest design standards and codes of practice.
8.	Liaise with and manage specialist consultants to provide structural advice to CBC directorates.
9.	Undertake forensic engineering, investigating and reporting on building failures, negotiating with insurers, loss adjusters and external consultants. Undertaking design and supervision of remedial works.
10.	Undertake structural condition surveys and detailed reports of all CBC properties and dwellings on request.
11.	Ensure compliance with the Health and Safety at Work Act. CDM Regs 2015 and other associated legislation in respect of the Groups' activities e.g. Building Regulations, Party Wall Act, Defective Dwelling Act.

12.	Ensure that all enquiries relating to structural engineering issues are addressed within specified time scales.
13.	To work in partnership with other stakeholders and external organisations and assist with queries as required.
14.	Complete as directed all other reasonable duties commensurate to the scale and seniority of the post.
