Job Overview

• To provide and maintain a clean and tidy leisure centre throughout the building including all areas as detailed above • Maintain the high standards of cleanliness in all areas as set out in the cleaning schedules. • To use cleaning equipment, chemicals and materials to undertake cleaning activities including, mopping and vacuuming, in accordance with the operational standards. • Ensure cleaning equipment and chemicals are kept and stored in accordance with the operating standards. • Act promptly to resolve any issues, ensuring the safety of people using these facilities. • To undertake any mandatory training and development, appropriate to the current and future needs of the post, including manual handling, COSHH and health and safety training. • To use mechanical equipment where necessary. • Assist with occasional light gardening duties and simple maintenance tasks. • Ensure that all relevant Health & Safety guidelines are always adhered to. • Contribute to a harmonious and productive staff working relationship. • Any other duties relevant to the post which may be assigned by a Leisure Supervisor / Manager.
