Guidance for Candidates

Candidates must apply through the agreed application form. The application form and any personal supporting statement will be used in drawing up short lists for interview. Candidates should ensure that they provide evidence that they meet the essential requirements as a minimum, in order to be eligible for short listing.

Visits to the school are warmly welcomed.

The interview panel will consist of senior staff of the school. At interview, short listed candidates will be expected to answer questions about professional knowledge, experience and abilities as well as questions regarding personal skills and qualities. The interview will also look at knowledge and understanding of safeguarding and promoting the welfare of children.

Short listed candidates will also be expected to teach an observed teaching activity. The content of this activity will be given to candidates before the interview.

The candidate must provide details of two references, one of which must be the last employer. References will be sought before interview, and the contents of these may be discussed.

Candidates will be given the opportunity to self-disclose any convictions or cautions that may be identified through the DBS check.
