Job Purpose			
To act on behalf of, and deputise for the Harbour Master in their absence, to provide support in the provision of delivering a maritime administration for the Falkland Islands.			
Main Accountabilities:			
- Understudy the Harbour Master continuously to fully understand the role and enhance the Falkland Island Government's ability to remain resilient in the Harbour Master's absence. - Task the Assistant Harbour Master's with respect to harbour control, harbour patrols, incident response, enforcement, inspections of vessels and inspections of facilities. - Develop new policies and procedures to support the implementation of the Harbours and Ports Ordinance 2017. - Promote safe navigation within port limits and implement the Port Marine Safety Code (PMSC) as applicable to the Falkland Islands (FI). Ensure port stakeholders manage their assets as per the PMSC. - As directed by the Harbour Master liaise with the Maritime and Coastguard Agency (MCA), Foreign, Commonwealth and Development Office (FCDO) and FI Attorney General to support the delivery of the Maritime Authority and other appropriate legislative matters. - Produce and oversee distribution of maritime information notices and liaise with local shipping and fishing companies to provide maritime assistance and guidance. - Oversee the installation and operation of a comprehensive upgrade to the Islands' Global Maritime Distress and Safety System (GMDSS) communications. - Provide and maintain Aids to Navigation (AtoNs) to improve shipping safety. - Development of policy and implementation of the Small Commercial Vessel (SCV) Code and oversee the Small Vessel Register. - Work alongside the Communications Regulator to manage marine radio licencing. - Assist in maintaining the National Oil Spill Contingency Plan (NOSCP), including procurement and maintenance of equipment, conducting drills and delivering training. - Oversee the management and execution of the Port Facility Security Plan (PFSP). - Undertake marine accident investigation as directed by the Harbour Master; prepare reports for relevant authorities following an incident. - As an appropriately trained and qualified REG Category 2 Inspector, carry out Port State inspections of foreign-flagged merchant and fishing vessels. - As an appropriately trained Port Health officer, carry out Ship Sanitation Inspections of all vessel types. - Work positively with local stakeholders to improve maritime safety. - Support the delivery and management of an effective pilotage service. - Promote safety awareness by heading up the annual sea safety campaign.

Additional Information

The Deputy Harbour Master is expected to operate at a high level implementing and taking decisions within agreed policy as well as developing policy in relevant areas. The Deputy Harbour Master is supported by the Assistant Harbour Master's and the development of the Maritime Authority is seen to be key in the development of maritime issues. The Deputy Harbour Master will be required to be on an on-call rota which provides 24 hour cover in the event of a maritime emergency. Extra hours of working are sometimes necessary to meet operational requirements. The job description is not an exclusive or exhaustive definition of your duties. You shall undertake such additional or other duties as may reasonably be required by FIG commensurate with your role and grade.

Due to the involvement in Falkland Islands Security matters, successful applicants may need to undergo and successfully complete security checks.
